IN CONSIDERATION of being permitted to participate in any way in Chain Reaction Cycling Club ("Club") sponsored bicycling activities ("Activity") I, for myself, my personal representatives, assigns, & next of kin:

1. ACKNOWLEDGE, AGREE & REPRESENT that I understand the nature of bicycling activities & that I am qualified, in good health, & in proper physical condition to participate in such Activity. I further acknowledge the Activity will be conducted over public roads & facilities open to the public during the Activity & upon which the hazards of traveling are to be expected. I further agree & warrant that if at any time I believe conditions to be unsafe, I will immediately discontinue further participation in the Activity.
2. FULLY UNDERSTAND THAT: (A) BICYCLING ACTIVITIES INVOLVE RISKS & DANGERS OF SERIOUS BODILY INJURY, INCLUDING PERMANENT DISABILITY, PARALYSIS & DEATH ("RISKS"); (B) these risks/dangers may be caused by my own actions or inactions, the actions or inactions of others participating in the Activity, the conditions in which the Activity takes place, or THE NEGLIGENCE OF THE "RELEASEES" NAMED BELOW; (C) there may be OTHER RISKS & SOCIAL & ECONOMIC LOSSES either not known to me or not readily foreseeable at this time; & I FULLY ACCEPT & ASSUME ALL SUCH RISKS & ALL RESPONSIBILITY FOR LOSSES, COSTS & DAMAGES I incur as a result of my participation in this Activity.
3. HEREBY RELEASE, DISCHARGE, & COVENANT NOT TO SUE the Club, their respective administrators, directors, officers, volunteers, & employees, other participants, any advertiser, & if applicable, owners & tenants of premises on which the Activity takes place, (each considered one of the "RELEASEES" herein) FROM ALL LIABILITY, CLAIMS, DEMANDS, LOSSES, OR DAMAGES ON MY ACCOUNT CAUSED IN WHOLE OR IN PART THE NEGLIGENCE OF THE "RELEASEES" OR OTHERWISE, INCLUDING NEGLIGENCE RESCUE OPERATIONS; & I FURTHER AGREE that if, despite this RELEASE & WAIVER OF LIABILITY, ASSUMPTION OF RISKS & INDEMNITY AGREEMENT, I or anyone on my behalf, makes a claim against any of the Releasees, I WILL INDEMNIFY, SAVE, & HOLD HARMLESS EACH OF THE RELEASEES from any litigation expenses, attorney fees, loss, liability, damage, or cost which any may occur as the result of such claim.
4. AFFIRM THAT MY BICYCLE IS IN SAFE OPERATING CONDITION & that I am competent to handle it under all conditions met on & off public roads. I am aware of & shall abide by all traffic laws & regulations. I WILL WEAR A HELMET (CPSC, ASTM, OR SNELL APPROVED) WHILE RIDING MY BICYCLE IN THE ACTIVITY, & WILL PRACTICE COURTESY & SAFETY WHILE RIDING MY BICYCLE IN THE ACTIVITY.

I HAVE READ THIS AGREEMENT, FULLY UNDERSTAND ITS TERMS & UNDERSTAND THAT I HAVE GIVEN UP SUBSTANTIAL RIGHTS BY SIGNING IT, & HAVE SIGNED BELOW FREELY & WITHOUT ANY INDUCEMENT OR ASSURANCE OF ANY NATURE & INTEND IT TO BE A COMPLETE & UNCONDITIONAL RELEASE OF ALL LIABILITY TO THE GREATEST EXTENT ALLOWED BY LAW & AGREE THAT IF ANY PORTION OF THIS AGREEMENT IS HELD TO BE INVALID, THE BALANCE, NOT WITHSTANDING, SHALL CONTINUE IN FULL FORCE & EFFECT.
